DIRECT SERVICE CAMP PROMISE JETT FOUNDATION'S SUMMER CAMP, CALLED CAMP PROMISE, HAS BEEN THE ONLY CAMP IN THE COUNTRY FOR KIDS, TEENS, AND ADULTS WITH MUSCULAR DYSTROPHY AND NEUROMUSCULAR DISEASES SINCE 2009 WITH NO UPPER AGE LIMIT AND A COMPLETE ON-SITE, 24-HOUR MEDICAL TEAM, JETT PROVIDES A FREE AND UNIQUE OPPORTUNITY FOR CAMPERS TO EXPERIENCE A WEEK OF INDEPENDENCE, FREEDOM AND NEW OPPORTUNITIES AWAY FROM THE ROUTINE OF DAILY LIFE AT CAMP PROMISE, CAMPER-FOCUSED PROGRAMMING IS PROVIDED THAT BUILDS INDEPENDENCE, CONFIDENCE AND LIFE SKILLS THROUGH TRADITIONAL CAMP ACTIVITIES AND BY BRINGING CAMPERS NEW EXPERIENCES THROUGH ADAPTATION, TECHNOLOGY, CREATIVITY, AND SPECIAL GUESTS. IN 2016, JETT SERVED MORE THAN 70 CAMPERS AND WORKED WITH 85 VOLUNTEERS ACROSS 3 WEEKS IN 3 DIFFERENT GEOGRAPHICAL LOCATIONS, EAST, WEST AND THE ROCKIES. IN 2015, JETT SERVED MORE THAN 65 CAMPERS AND WORKED WITH 85 VOLUNTEERS. IT IS NUMBERS LIKE THESE, IN ADDITION TO THE INTANGIBLE MEMORIES OF CAMP, THROUGH WHICH WE MEASURE AND BELIEVE IN THE MAGNITUDE OF THE IMPACT OF CAMP PROMISE ROUNDTABLES. THE JETT FOUNDATION HAS PARTNERED WITH OTHER DUCHENNE ORGANIZATIONS, INSTITUTIONS, PHARMACEUTICAL COMPANIES, CLINICIANS AND OTHER EXPERTS AROUND THE COUNTRY IN A SERIES OF REGIONAL ROUNDTABLE CLINICAL TRIAL DISCUSSIONS. THESE EVENTS HELP INFORM AND CREATE A DISCUSSION AROUND CLINICAL TRIALS OPTIONS BOTH LOCALLY AND WORLDWIDE. WITH THE DEVELOPMENT OF NEARLY 60 ONGOING DRUG TRIALS IN THE DUCHENNE SPACE, JETT FOUNDATION HAS BECOME A LEADER IN EDUCATING FAMILIES AND THE BROADER COMMUNITY ABOUT CLINICAL TRIALS. JETTRIDE JETTRIDE IS A DIRECT SERVICE PROGRAM FOR SIBLINGS AND CLOSE FRIENDS OF THOSE AFFLICTED WITH DUCHENNE. THE JETTRIDE GIVES THESE INDIVIDUALS THE OPPORTUNITY TO CONNECT WITH OTHER TEENS WHO ARE LIVING THROUGH THE SAME EXPERIENCES IN ORDER TO BUILD LIFELONG FRIENDSHIP.

EDUCATION THE JETT FOUNDATION HAS SPONSORED EDUCATIONAL FORUMS ACROSS THE COUNTRY FOR PARENTS, CAREGIVERS, FRIENDS, FAMILY AND RESEARCHERS SINCE 2007. IT IS THE ONLY PROGRAM LIKE IT IN THE COUNTRY AND FILLS A MUCH NEEDED GAP IN SERVICES FOR FAMILIES AND INDIVIDUALS AFFECTED BY DUCHENNE MUSCULAR DYSTROPHY. THE JETT FOUNDATION ALSO PARTICIPATES IN BOTH NATIONAL AND INTERNATIONAL CONFERENCES TO SHARE OUR SUCCESSES AND TO CONTINUALLY EDUCATE OURSELVES SO THAT WE CAN CONTINUE TO ASSIST CHILDREN AND FAMILIES AS THEY NAVIGATE THE PERSONAL, MEDICAL AND COMMUNITY CHALLENGES OF LIVING WITH DUCHENNE. JETT FOUNDATION FOCUSES ON WORKING WITH INDUSTRY, REGULATORY AGENCIES AND THE PATIENT COMMUNITY IN ORDER TO GAIN ACCESS TO SAFE AND EFFECTIVE THERAPEUTICS AS QUICKLY AS POSSIBLE. THE JETT FOUNDATION IS IMPROVING THE WAY PATIENTS AND THEIR COMMUNITIES ARE EDUCATED ABOUT DUCHENNE AND THE REGULATORY SYSTEM. THE ORGANIZATION HAS ESTABLISHED CREDIBILITY, ACCESS AND ACTION BASED IMPACT WITH THE COMMUNITY, CONGRESS AND AGENCY REPRESENTATIVE, SOMETHING FEW ORGANIZATIONS HAVE BEEN ABLE TO ACHIEVE IN DUCHENNE OR ANY OTHER RARE OR LIFE THREATENING DISEASE. THIS HAS REQUIRED A LARGE-SCALE COORDINATION EFFORT OF EXPERTS, CONFERENCES, CONGRESSIONAL MEETINGS AND OVERSIGHT HEARING. JETT HAS BROUGHT EXPERTS IN THE RESEARCH AND MEDICAL FIELDS, TOGETHER WITH PATIENT ADVOCATES TO EDUCATE THE FDA ON THE URGENT NEED FOR ACCELERATED APPROVAL. THE ORGANIZATION MADE TRAVEL SCHOLARSHIPS AVAILABLE TO THOSE PATIENTS WHO WOULD OTHERWISE NOT BE ABLE TO ATTEND THESE MEETINGS, AND FINAL ATTENDANCE APPROACHED NEARLY 1,000 AT A SINGLE ADVISORY COMMITTEE MEETING IN 2016, THE LARGEST IN FDA HISTORY.
