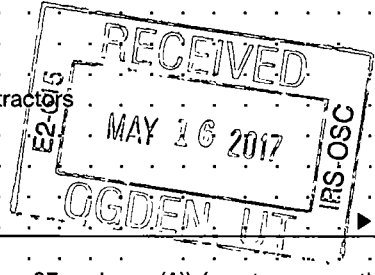



Part III, Statement of Program Service Accomplishments:

The organization's primary exempt purpose is "to engage in charitable activities in less developed nations...in pursuit of lasting beneficial advancement for those countries [which] may include education, economic development, and support of Christian institutions. It may also respond to compelling needs for assistance in the areas of food, shelter and medical care."

To that end, (1) the grants noted in Part III of Form 990-EZ were distributed; (2) personal work was undertaken by Foresight resource people from the United States: (a) Nepali leaders were trained and supported to develop and expand the operations of a model elementary school, National Bethel Academy, in the town of Trishuli, Nepal through teacher training, organizational development, and financial support; and (b) educational support and vocational guidance was provided to 17 young men and women who have "graduated" from a supportive home run by Prison Fellowship Nepal.

Travel for this work was mostly paid by the expense funds included in line 16 of Part I.
