Its primary lending products are residential real estate and consumer loans and its primary share products are checking, savings and term certificate accounts. The Credit Union has over 47,300 members. The membership is primarily limited to those employees, faculty, students, and alumni of Harvard University and its affiliated hospitals.

The Credit Union has evaluated its tax positions as of December 31, 2016 and 2015 and concluded that there are no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Credit Union files Form 990 in the U.S. federal jurisdiction and the state of Massachusetts. The Credit Union is no longer subject to examination by the Internal Revenue Service for years before 2014.
