The Trustees of the Warburton Chapel were incorporated by the Connecticut General Assembly in 1866, when several members of the First Church Christ in Hartford (Center Church) donated funds "for the purpose of erecting and maintaining a chapel, and of sustaining a mission sabbath school and religious service in the city of Hartford." This charter was amended in 1947 to "increase the amount of property that may be held by the Corporation and to assure such property be held exclusively and perpetually for educational, religious and charitable purposes." Although the original Chapel building is no longer in existence, the Trustees of the Warburton Chapel continue to support First Church in its education, mission, outreach, and social justice ministries. Direct grants and other support are given to the church and to closely related organizations with which it partners.

Part IV Section D Line 3

The Trustees of Warburton Chapel are elected from the membership of First Church of Christ. The minister of the church and the director of the Church Camp serve as Trustees, ensuring significant input from the supported organizations in the use of income and assets. The supported organizations make known each year their priorities and needs, and funds are disbursed during the year to assist them in meeting their goals in line with the objectives of the Trust. The invested assets of the Warburton Trust are managed together with the Restricted Endowment of First Church by a Joint Investment Committee, so there is a common investment policy for the supporting and supported organizations.

Distributions to First Church of Christ in Hartford. As noted above, members and leaders of the church serve as Trustees of the supporting organization formed to extend and support its programs 150 years ago. A joint investment committee and inclusion of a report from the Warburton Trustees in the Annual Report of the Church are further indications of attentiveness and responsiveness. The distributions to First Church provide major support to the education, outreach, and social justice programs without which they could not continue.
