We research, write & publish reports, conduct public education and sponsor forums and meetings. During 2016 our work focused on stopping cuts to Medicaid, contesting hospital consolidations, contesting corporate mergers of health insurers, clean energy, environmental hazards, jobs & the economy, equity in education and CT's clean elections law.

We build coalitions with other nonprofit organizations, unions and churches to address public policy questions and to provide outreach and education services to their members. During 2016 our coalition work focused on stopping cuts to Medicaid, contesting hospital consolidations, contesting corporate mergers of health insurers, advancing solar energy, equity in education, consumer protections in debt collection processes, development of our state's Comprehensive Energy Plan, and protecting its clean elections law.
