Funders for a Just Economy NFG’s longest standing working group, formerly known as the Working Group on Labor and Community Partnerships, celebrated its 20th year in 2016 a milestone for this funder community and an opportunity to build upon our educational strategies moving forward The working group engaged in a strategic planning and communications rebranding process, changing its name to Funders for a Just Economy and producing a video documenting a history of its achievements FJE had a significant impact on the programming for the June 2016 NFG national conference FJE led conference seven sessions, including three workshops on economic justice and worker rights, two experiential learning tours that took funders to community groups in the Bay Area to learn about their programmatic work, and two networking events for funders to meet key influencers in the worker protection field FJE continued to provide educational resources to it community of funders through webinars and in-person meetings For example, in August, funders learned about how community groups are using new social media strategies to build on-the-ground and online organizing programs and work with partners to seed new experiments around scale and sustainability to maximize their impact

Form 990, Part III, Line 4b:

Funders for Justice NFG's Funders for Justice initiative has blossomed into a dynamic organizing space for individual grantmakers, donor networks, and affinity groups to connect with each other and with the movement for racial justice and police accountability across the country FFJ's network has grown to 300 members, whom we provide opportunities to inform strategy and funding by learning about the work of organizations in the field, connecting with funder peers and finding thought leadership and other resources to help them integrate a social change lens to their grantmaking and funder organizing Funders participating in FFJ have collectively committed \$30 million in grant dollars and donor organizing for racial justice and police accountability work in 2015, 2016 and beyond FFJ provides direct resources and funder-field connections for its members, enabling them to make grants when and where they are most needed FFJ and its web portal have far exceeded our early goals and hopes, emerging as an innovative platform for funder organizing, collecting data, facilitating pledges, surveying members, and providing information about organizing groups and grantmaking The FFJ website with over 40,000 views is regularly updated with thought leadership in the field as well as in philanthropy, with a special focus on funders taking public stands in support of activists Additionally, FFJ staff regularly email members directly with updates from the field as well as an array of funding needs and opportunities for joint funding with other members Members regularly tell us that FFJ's emails and peer networking have directly guided their grantmaking and collaborations, when new uprisings occur, FFJ's members frequently turn to us for resources and to help identify and amplify local funding needs and partnership opportunities In addition to ongoing programming such as its October 2016 webinar on Gender, Race and Criminalization, FFJ also played a leadership role in NFG's June 2016 national conference, hosting two panels, a learning tour, and office hours with FFJ staff and consultants Approximately 100 grantmakers participated in FFJ's conference programming, with participants reporting having implemented new grantmaking as a direct result of this programming

Form 990, Part III, Line 4c:

Grantmakers for Southern Progress Grantmakers for Southern Progress (GSP) continued its work to support the those who are least well off economically, politically, and socially in the South. As a national network with a southern focus, GSP has been invested in attracting national and southern funders as members and as a result our membership has grown over the past few years. Through strategic engagements in the region in the past year, GSP helped to cultivate working relationships between 25 southern and national funders who were not working together previously. GSP's successful March 2015 three-day funders' learning tour in commemoration of the 50th anniversary of the Bloody Sunday Civil Rights gave rise to several opportunities during the past year for GSP to partner with an array of different funders in promoting equitable structural change in the South. For example, GSP partnered with the Kresge Foundation to develop a mini tour of Selma in 2016 that has helped shaped Kresge's new investment in Alabama. This Selma work also laid the foundation for a funder organizing effort in 2016 led by GSP to save Head Start funding in parts of Alabama. Finally, in 2016 GSP continued its work with the National Committee on Responsive Philanthropy (NCRP) on the second iteration of its As the South Goes report. The research is focused on identifying best practices and approaches for funders to invest in the South that will lead to more equitable outcomes. The report is scheduled to be released in early 2017 and will include case studies, lessons learned, and informed recommendations for foundations.

Project Phoenix Project Phoenix is a year-long cohort collective learning program for funders who are focused on how to practically achieve a just transition to a "new economy and philanthropy's role in that transition. Project Phoenix defines this "new economy" as a democracy that works for all, an economy that provides good jobs and promotes local economic prosperity, and the growth of ecologically sustainable and non-extractive sectors. Project Phoenix participants met via webinar and in-person at least eight times during the year, with support and coordination from NFG. In addition to webinars and convenings, three site-visits were held to see relevant grantmaking and work in action. The content offered through these methods sought to increase members' capacity to influence and understand the intersection of key issues and reforms necessary to support a new regenerative and equitable, "people not profit focused" economy.
