In 2016, 30 new doctoral students drawn from 16 sub-Saharan African countries were awarded fellowships under the African Doctoral Dissertation Research Fellowship (ADDRF) program. The program has supported 203 students since its commencement in 2008. Sixty-seven percent of awardees (n=137) have successfully completed their studies. Almost all the graduates have remained in Africa and continue to be engaged in research. 2. The Consortium for Advanced Research Training in Africa (CARTA), an initiative involving 9 African universities, 4 African research institutes & selected northern partners has had 165 doctoral students undergo training, 27 joining in 2016. The program, was able to: - continue with a model collaborative doctoral training program with strong supervision and mentoring components. - strengthen infrastructure, skills & faculty commitment to lead & manage research initiatives within the institutions - contribute to the improvement of environments at African universities with the aim of facilitating and motivating researchers to stay and contribute to scholarly work within the region. 38 have successfully completed their studies and most of the graduates have been retained in their institutions in Africa.

In 2016, among other achievements under this program:</u> - APHRC partnered with the Population Council to contribute to development and launch of the Nairobi City County's (NCC) Plan of Action to Strengthen School Health Programming. This Plan of Action incorporates comprehensive sexuality education for improved sexual and reproductive health outcomes among health outcomes among adolescents. - APHRC contributed to the inclusion of family planning as a budget line item for sub-national government in Western Kenya. This followed implementation of a family planning campaign that resulted in a significant increase in the number of women using long-term contraceptive methods. - Co-hosted a regional conference on abortion in Addis Ababa, Ethiopia. During the conference, delegates adopted the Addis Declaration which calls on African countries to ensure safe access to quality reproductive health care including reliable contraception and post-abortion care for women and girls.

In 2016, among other achievements under this program: - APHRC played a key role in conducting Kenya's first-ever STEP-Wise Survey in 2016. The STEP-Wise Survey is a tool developed by the WHO to aid collection, analysis & dissemination of data on NCDs. This was towards addressing African countries need for reliable data on NCDs at the national and sub-national level if they are to effectively tackle the emerging NCD epidemic. - APHRC continued its work with various stakeholders including the United Nations Children's Fund (UNICEF) to promote better nutrition among infants and young children. Our research evidence contributed to development of Implementation Guidelines for the Baby Friendly Community Initiative (BFCl) in Kenya. The guidelines were launched nationally & provide practical recommendations on how communities can promote exclusive breastfeeding for the first 6 months of an infant's life in line with WHO recommendations. - APHRC was awarded a certificate of recognition by Kenya's Ministry of Health to celebrate the Center's Center's commitment in advocating for a supportive work environment for breastfeeding mothers.
