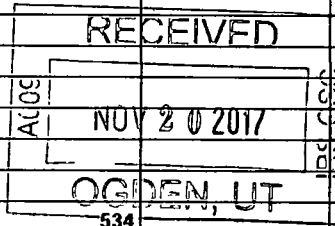

Expenses

- 1 People Against Impaired Drivers organized a 5K/5 mile community run in a city park and along a greenbelt in Idaho Falls to promote public awareness of traffic safety, and the devastating consequences if there is a lapse in traffic safety. Our daughter, Cady, was killed at age 11 in a motor vehicle crash caused by an impaired driver.
- 2 The run also promoted physical fitness and linked it to safe driving. Approximately 150 runners participated in the run.
- 3 People Against Impaired Drivers purchased two automated external defibrillators (AEDs) and donated them to local public schools. AEDs can be used to treat sudden cardiac arrest, which is a common cause of death of young athletes.
- 4 The run provided a venue for the city fire department to demonstrate CPR techniques to approximately 150 runners and their supporters.
