Neither the Board nor any Committee of the Board shall vote upon any proposed matter, transaction, contract, or arrangement in connection with which an actual or possible conflict of interest has been disclosed by a Board Member until such time as the Ethics and Elections Committee has addressed the actual or possible conflict of interest. Also, each Board Member shall annually sign a statement which affirms that such person (i) Has received a copy of the current conflict of interest policy, (ii) Has read and understands the policy, (iii) Has agreed to comply with the policy, and (iv) Understands that the Association is a non-profit organization and that in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.
