nutrition education programs, job training, direct services targeted at children, senior citizens, veterans, and others at risk of food insecurity Island Harvest has achieved a four-star rating by Charity Navigator, their highest rating, three years running Charity Navigator recognized Island Harvest with a certificate noting that a 4-star rating verifies that Island Harvest exceeds industry standards and outperforms most charities in its area of work, nationally Only 14% of the charities it evaluates have received at least 3 consecutive 4-star evaluations, indicating that Island Harvest
