Home-based licensed continuing care retirement program serving Western PA Longwood at Home is licensed by the Pennsylvania Department of Insurance and offers a compelling alternative to long-term care insurance for healthy, active older adults who would prefer to receive in-home services as their care needs may increase over time. As Western Pennsylvania's first and only continuing care at-home membership program, Longwood at Home was developed, and continues to be operated by Presbyterian SeniorCare. Established on January 25, 1928 in the Commonwealth of Pennsylvania, Presbyterian SeniorCare is a not-for-profit, charitable organization which provides facilities, services and programs for enhancing the quality of life of older adults.
