ASC Topic 740 also provides guidance on recognition, classification, interest and penalties on income taxes, accounting in interim periods and requires increased disclosures. The Trust Fund adopted the provisions of ASC Topic 740 on January 1, 2009. This interpretation also clarifies that the trustee's determination of the taxable status of the Trust Fund, including its status as a tax-exempt not-for-profit entity, is subject to the standards required for accounting for uncertainty in income taxes. The interpretation was effective for interim and annual periods ending after September 15, 2009. For the year ended December 31, 2016, the Trust Fund adopted the application of accounting for uncertainty in income taxes in accordance with ASC Topic 740. No financial reporting requirements are associated with this adoption.
