Exercise of Discretion to Dissolve Trust

WHEREAS

1. By a Declaration of Trust dated May 24, 1996, the Declaration of Trust between John W. Merwether and Mimi Murray Merwether, as Donors and a Trustee, a voluntary charitable trust was created now known as the Merwether Foundation (the "Foundation").

2. Mimi Murray Merwether ceased to act as a trustee of the Foundation by reason of her death on September 28, 2017, and John W. Merwether thereafter acted and is currently acting as the sole Trustee of the Foundation.

3. Subdivision A of Article III of the Declaration provides as follows:

A. The duration of the Foundation shall be unlimited; provided, however, the Trustees may, in their sole and absolute discretion, determine at any time to terminate the Foundation. In such case, or in the event of a termination or dissolution of the Foundation for any reason, the assets of the Foundation as then constituted shall be transferred, conveyed and given over to or for the use of such one or more qualified charitable organizations for exclusively charitable purposes, or in the United States, any state, territory, possession or political subdivision thereof for exclusively public purposes, as the Trustees select in their sole and absolute discretion.

4. The undersigned, John W. Merwether, the sole current Trustee of the Foundation, pursuant to Subdivision A of Article III of the Declaration, desires to dissolve the Foundation effective as of December 31, 2016.

NOW, FURTHER, the undersigned, John W. Merwether, as the sole Trustee of the Foundation, pursuant to Subdivision A of Article III of the Declaration, does hereby dissolve the Foundation effective as of December 31, 2016.
