

The grantee of the grant of \$569,962 listed in Part II, line 1 is Israel Free Loan Association ("Israel Free Loan"). Israel Free Loan is an Israeli not for profit corporation which files reports with, is under the supervision of, and subject to audit by the Registrar of Non-Profit Organizations at the Israel ministry of Justice and the Non-Profit Division of the Israel Finance Ministry. Israel Free Loan is a highly regarded organization with a longstanding history and success rate. Over the last 26 years, Israel Free Loan has provided over \$250 million in interest-free loans to low-middle income Israelis and small businesses. With a default rate of less than 1.7%, loans are repaid almost entirely, thus recycling donations to be used for further loans. On average, every dollar donated has been recycled 5 times since the organization was founded in 1990. Israel Free Loan helps close to 3,000 individuals, families, and small businesses each year helping them maintain financial stability in Israel. Of the grant to Israel Free Loan in 2016, \$69,562 was for overhead in connection with interest free loan operations and the balance was for the establishment of or addition to loan funds for interest free loans to low to middle income individuals and families and to small businesses.
