In accordance with NYPMIFA, the Society considers the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds: (1) the duration and preservation of the various funds, (2) the purposes of the donor-restricted endowment funds, (3) general economic conditions, (4) the possible effect of inflation and deflation, (5) the expected total return from income and the appreciation of investments, (6) other resources of the Society, and (7) the Society's investment policies. The Society's permanently restricted endowment fund was established prior to the involvement of any current board members. The Board of Directors has taken the position to preserve the fair value of the original gift and has designated that this fund will continue to be preserved until such time as the original restriction becomes known or the Society petitions the Attorney General to release the restriction. The Society has adopted an investment policy with the stated primary objective to preserve capital of the above endowments. The secondary objective is to maintain purchasing power by growing the investments at an annual rate that equals or exceeds the rate of inflation. The tertiary objective is growth and income. Over a five year rolling period, the investment should closely track the return of the balanced market indices. The endowment fund is managed with the same objective and is comprised of an allocation of marketable securities.</p>
