All assistance is available based on demonstrated need without regard to race, color, religion, gender, national origin, age, or physical or mental handicap. Scholarships are awarded on a sliding fee scale and can be applied to a portion of the cost of a membership or program. Scholarship determinations are based upon household gross income and household size as they relate to the published federal poverty level. Extenuating circumstances may be considered. Anyone living or working within the SRY service area with annual household income plus cash reflected on current bank statements adding to less than 300% of the Federal Poverty Level as defined by the US Department of Health and Human Services is eligible. Homeless individuals are automatically eligible for scholarships. Scholarships are provided in the form of a percentage discount off of the fee for a membership or program. The percentage discount provided is based on a sliding scale adopted by the board of directors. Applicants may be asked to pay a portion of fees based on where they fall on the scale.
