Green Schoolyards for Healthy Communities - Green Schoolyards for Healthy Communities, a joint initiative of the Children & Nature Network (C&NN) in partnership with the National League of Cities Institute for Youth Education and Families (IYEF), will engage education leaders, cross-sector practitioners, policy makers and community leaders to promote green schoolyards across the nation. Cities Connecting Children to Nature - In partnership with that National League of Cities Institute (NLCI), C&NN is working with municipalities and cross-sector community partners in cities to improve health, education, and quality of life for low-income residents through increasing nature access. City-wide scans in seven pilot cities have identified strengths, gaps, and shared metrics that have informed city plans to connect children and families to nature, specifically in low-income communities.
