THE PAWLING FREE LIBRARY IS A FREE LENDING LIBRARY THAT ALSO PROVIDES VARIOUS PUBLIC PROGRAMS FOR ADULTS, TEENS AND CHILDREN. PROGRAMS ARE GEARED TOWARDS AN INCREASE IN LEARNING, LITERACY AND EDUCATION AS WELL AS ENTERTAINMENT AND PERSONAL IMPROVEMENT. THESE SERVICES ARE OFFERED TO THE ENTIRE COMMUNITY OF PAWLING AND HOLMES DURING 2016 THERE WERE 4,631 LIBRARY CARDHOLDERS (OF THE TOTAL POPULATION OF 8,463), WITH 68,402 WALK-INS, 64,625 WEBSITE HITS, 3,782 REFERENCES, 47,168 PHYSICAL CIRCULATION, AND 3,699 E-FORMAT CIRCULATION.
