The Wild Earth Society, Incorporated, d/b/a Wildlands Network, is a Vermont corporation with its headquarters located in Seattle, Washington. Wildlands Network's mission is to reconnect nature across North America, and to inspire similar efforts worldwide. We focus on the protection and creation of large-scale wildlife corridors to enable wide-ranging wildlife to adapt to a changing climate and to facilitate the restoration of apex predators. We began a camera trap study in the red wolf recovery area of North Carolina to show the ecological benefits of having red wolves on the landscape. We organized two successful rallies to save the red wolf and combined numerous petitions into one that boasted 500,000 names. Our work compelled several US House and Senate members to sign on to oversight letters to the USFWS, successfully persuading the agency to not abandon the red wolf recovery program. We convinced federal transport authorities in Mexico to spare 16 miles of sensitive riparian habitat from the impact of a planned bypass along Highway 2. Wildlands Network compiled the first-ever borderlands connectivity report identifying the efforts of organizations and government agencies in Mexico along and near the border wall concerning wildlife habitat and the impacts of border infrastructure and need for binational cooperation. Wildlands Network built support for the creation of the 87,000-acre Katahdin Woods & Waters National Monument in Maine, and added several hundred acres of protected land to Split Rock Wildway, one of our flagship projects and perfect future cougar habitat in the Northeast. Wildlands Network galvanized public support for national-spotlight campaigns within the Western Wildway including Bears Ears National Monument and the proposed Greater Grand Canyon Heritage National Monument. We created an online Public Lands Planning Atlas to facilitate awareness and allow timely engagement concerning proposed management changes to federal public lands.
