HUMANITARIAN AID PROGRAM

Established in 1996, the WFH Humanitarian Aid Program channels the world's largest supply of donated clotting factor concentrates (CFCs) to people with bleeding disorders. Treatment products are received as donations by the organization and distributed to developing countries for treatment of persons with hemophilia and related bleeding disorders. Product donations enable the organization to help thousands of people in more than 55 developing countries per year.

SUSAN SKINNER MEMORIAL FUND

This is an endowment fund which supports, through scholarship payments, the training and education of young women with bleeding disorders. The fund is managed with the goal of generating enough funds to distribute scholarships while maintaining the long-term viability. Until the SSMF has a five year history of investment returns, the annual distribution rate will not exceed 4% of the prior year's principal balance.

WFH RESEARCH PROGRAM

The WFH Research Program encourages international collaborations to support epidemiological and clinical research that will build the evidence base for the optimal management of inherited bleeding disorders. It fills a unique need within the global community and has great potential to add value to the existing evidence base.

The WFH USA Board of Directors agreed to designate the WFH Research Program as an Additional Approved Project as defined in the Fiscal Sponsorship agreement between WFH USA and the WFH. In accordance with this agreement, WFH USA solicits donors based in the United States to support the WFH Research Program.

Procedures for humanitarian aid shipments: Humanitarian aid donations are sent to either governmental hospitals where there is a Hemophilia Treatment Center or Registered Hemophilia Associations in the recipient countries. They are sent by international couriers such as FedEx, DHL and DSV. The international courier requires us to provide them with specific information such as the contact name, address and telephone number where the shipment will be sent.

The international courier provides us with an airway bill with a tracking number to track the shipment and to ensure that the shipment has been delivered and signed by the person it was addressed to in the recipient country. We require that the recipient countries send us an acknowledgement of receipt form that is to be signed by the person that the shipment was addressed to or their representative. The acknowledgement of receipt specifies what product has been sent, brand name, manufacturer, lot number, quantity of the product and expiry date. In addition to this we ask the recipient countries to provide a detailed utilization report.

In 2016, the administrative services provided by WFH without compensation totaled to \$187,317.

2) Allocation for approved projects

Effective January 1, 2011 World Federation of Hemophilia USA and WFH signed a Fiscal Sponsorship Agreement, whereby WFH USA serves as the fiscal sponsor of WFH in the United States with respect to the Humanitarian Aid Program - the jointly conducted program that channels the world's largest supply of donated clotting factor concentrates (CFCs) to people with bleeding disorders in more than 55 developing countries. 1. The World Federation of Hemophilia USA is an affiliated organization of World Federation of Hemophilia (WFH) based in Montreal, Canada.

Effective January 1, 2011, WFH USA and WFH signed a Services Agreement whereby WFH provides certain services to WFH USA without compensation and the rest of those services solely for reimbursement by WFH USA. The compensation paid by WFH to its own employees for time spent on providing those services as well as overhead cost related to those services is considered non-reimbursable.

This is treated as a grant in kind and recorded as revenue in the WFH USA books. In 2016, the monetary value of services donated by WFH was \$187,317. The amount was not declared as contribution on Part VIII of the Form 990.

2. WFH USA receives a research report on global forecasts of the factors VIII and IX market from the Marketing Research Bureau. The report is a great resource and an invaluable source of information for the organization's policy work. In 2016, the market value of the report was \$12,700. The amount was recorded as a gift-in-kind in WFH USA books, but was excluded from Part VIII of the Form 990.
