Hosted by Global Compact Network UAE, the four-day series of events entitled Making Global Goals Local Business Dubai explored the actions and partnerships needed to advance the SDGs at the local level, particularly in the realm of peace and the humanitarian agenda. The series focused on encouraging companies to move from awareness to action. Other notable events include 2016 World Economic Forum High-Level Meeting on UN-Business Partnerships & CEO Dinner (New York), Signature Ceremony of the Paris Climate Agreement (New York), High-Level Political Forum (New York), UN Private Sector Forum, Making Global Goals Local Business (Dubai), Annual Business for Peace Event (Dubai), 2016 LEAD Symposium (Cambridge), and COP 22/CMP 12 High-Level Meeting on Climate Change (Marrakech). LAUNCH OF ACTION PLATFORMS An important part of the 2020 Strategy is the update of existing issue areas into new more systematic Action Platforms - all seen through the lenses of the SDGs. This has resulted in the creation of 9 new Action Platforms, including The Blueprint for SDG Leadership, as well as a Global Opportunity Explorer that will gather best practices from companies engaged across all of the platforms and beyond. These platforms are intended to more closely tie the Global Compacts day-to-day work to current global events and to make its thematic work more time-bound and output oriented.
