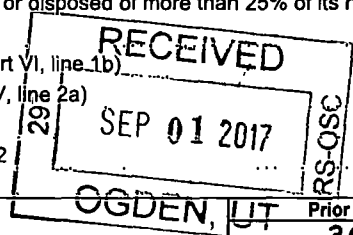

The Organization conducted three (3) NCAA Women Coaches Academy. The Academy is a 4-day long training seminar that focuses on training and education of women coaches in management, communication, ethics and coaching philosophies. This seminar served 143 women in 2016.

4b (Code:) (Expenses \$ 50,823 including grants of\$) (Revenue \$ 16,830)

The organization conducted three (3) one-day regional training workshops for women coaches, administrators and interested students in three different regions of the country. These workshops feature expert speakers who focus on relevant issues and common challenges and offer practical ideas that can be implemented immediately. These seminars served 255 women in 2016. The organization co-hosted a fourth one-day regional training with the Tucker Center for Research on Girls & Women in Sport which served 215 women.

The organization conducted twelve (12) Meet & Greet Networking events for women coaches in different regions of the country typically associated with sport specific Coaching Associations' annual conferences.
