Started in 2003, the Foundation is a small totally volunteer organization based in Montgomery, Alabama. Since 2011, the Foundation has sponsored missionaries to work at Cambridge University, namely: Peter and Ilona Greyling, David and Sarah Ilman and Jon Thompson. In 2014, the Greylings determined to expand the influence of the Foundation and opened a branch in London and Edinburgh, Scotland. These servants serve as missionaries and conduct seminars, lectures, edit and distribute publications. The Foundation now has a summer program to provide educational opportunities to seminary students and other interested parties who want to more fully explore the broad heritage of the Christian faith and the influence individual Christians had on the development of modern western thought and culture. The work in Cambridge can be viewed on the website: [www.christianheritage.org.uk](http://www.christianheritage.org.uk). The Foundation also supports the Round Church which is the site for seminars, tours, bible studies and other classes for scholars and university students. The topics of the seminars are a variety of subjects all centered on religion and the impact the Christian faith had on early scholars and scientists and the significance of faith in everyday life. Since 2012 a number of other organizations based in the United Kingdom partnered with the Foundation to act as a fiscal agent to accept grants and donations to support other missionaries and projects including Morphe Arts, the United Christian Fellowship and the Christian Unions. Several foundations and individuals based in the United States count on the Foundation to accept funds and remit them to support other Christian organizations who share the same mission, but utilize different methods to achieve their goals, like Leith School of Art. Due to the small size of the organization, the costs involved and the desire to maximize funds to accomplish the mission of the Foundation no audit is conducted. Donors give to the organization and the funds are sent on a monthly basis to support the work of missionaries and programs they conduct. The missionaries all work under the laws of the United Kingdom. Some funds are used for operational expenses like the printing of bibles, books, articles and newsletters. Other monies are used to sponsor program like UCCF's UNCOVERED Gospel, various seminars, lectures, summer schools and debates. Forums are also conducted to explore and exchange ideas on the practical role of religion in society and the impact Christian thought had on the development of civilization. While churches and few organizations do make contributions, many of the funds come from individuals who make monthly donations. The donations are properly receipted when received and annually. The organization maintains one (1) bank account and has no endowment, interest bearing accounts, investments or other assets. The form 990 has many questions that simply do not apply to such a small volunteer organization. The Foundation has no employees, paid or otherwise and the directors give of their time without any form of renumeration. Expenses are kept to a minimum so that the bulk of the funds donated can be sent to support the programs, ministry and mission of the Foundation. Every effort has been made to provide proper and direct information in responses to all questions asked on the 990, but many things simply do not apply and could not apply to this organization. The organization did receive a 25% LLC interest in 2015, but will only realize income when property is actually sold as no income is generated currently.
