The RiverFirst Initiative is a 20-year vision for creating the next generation of parks along 5.5 miles of the Mississippi River in downtown Minneapolis. The Parks Foundation's goal is to work with Minneapolis Park & Recreation Board (MPRB) to realize the vision of extending the iconic string of parks and trails that line the Mississippi further north as outlined in the Above the Falls plan. When the RiverFirst vision is fully realized, the Mississippi River will be better connected to Minneapolis neighborhoods that have not benefited fully from the Grand Rounds and legacy parks that traditionally have defined Minneapolis for generations. MPF's role is to bring private philanthropy to RiverFirst and to engage the community in order to keep this vision fresh and a priority in the city. In 2016, the Parks Foundation (1) reached a milestone of \$12 million secured or committed to the RiverFirst Capital Campaign begun in 2015, (2) established a fund with The Minneapolis Foundation to hold campaign gifts through RiverFirst implementation, (3) launched the final pre-construction phase of Water Works, with an anticipated groundbreaking in 2017 and projected completion date of 2019, (4) partnered with the Minneapolis Park Board on land acquisition options related to the Great Northern Greenway River Link project, (5) implemented a summer-long community engagement and youth design program involving 16 youth design apprentices evaluation the Great Northern Greenway River Link site and its connections to North Minneapolis, and (6) communicated key project milestones demonstrating program momentum. Water Works is representative of an exciting addition to the Minneapolis park system and a feature of the future St. Anthony Falls Regional Park. In 2016, the Parks Foundation (1) retained, through a competitive RFP process, Damon Farber Landscape Architects and HGA Architects to lead a 12-firm working on schematic design for the Water Works Mezzanine Phase, (2) retained 106 group to lead cultural and historic resources evaluation of the Water Works site, (3) established plans for the deconstruction of the Fuji-ya building on-site in July 2017, effectively the start of project construction, (4) designed an innovative rainwater reuse system for the project and produced a video illustrating how well reuse rainwater for plumbing, irrigation, and water features, (5) secured a \$900,000 grant from the Mississippi Watershed Management Organization for the rainwater re-use system, and (6) promoted the importance of Water Works to the City of Minneapolis and the park system through social media, print and video. Through the Next Generation of Parks Lecture Series, the Parks Foundation invites global design innovators and local thought leaders to showcase the most exciting new park destinations and delve into important issues affecting our vibrant city and region. The aim of the program is to introduce the Twin Cities community to new, engaging and critically acclaimed work that focuses on specific 21st century approaches to comprehensive park planning and design. In 2016, MPF hosted two lectures that: (1) Highlighted urban planning, designed infrastructure and the role parks play in social and interpersonal wellbeing (Leila Araghi, Diba Tensile Architecture, September) and (2) the role parks and community design play in the revitalization of the City of Detroit (Maurice Cox, Detroit City Planner, November). We engaged more than 800 people through this speaker series and related events. The Parks Fellow is an adjunct position of the Minneapolis Parks Foundation that leverages expertise in park design and planning to address significant opportunities and issues facing our park system today and in the future. During 2015-2017, the inaugural Minneapolis Parks Fellow, Bruce Chamberlain, is concentrating on RiverFirst implementation, with an emphasis on Water Works and the Great Northern Greenway River Link. In addition, he is overseeing Research Assistants from the University of Minnesota and providing additional consulting services to MPRB through the Parks Foundation. In 2016, the Parks Fellow also (1) developed plans and processes for the deconstruction of the Fuji-ya building, (2) led design team in developing Water Works schematic design, (3) advanced the Water Works rainwater reuse strategy and secured a \$900,000 grant for the project, (4) continued facilitating Minneapolis Park Board and City of Minneapolis redevelopment strategy for Upper Harbor Terminal site. The Minneapolis Parks Foundation is host to one of the more unusual and iconic pieces of public art in the Minneapolis Park System. Minne the Lake Creature (pronounced "mini") is a floating sculpture inspired by the infamous "Surgeon's photo" of the Loch Ness Monster that has appeared each summer in various Minneapolis Lakes since 2009. In 2016, the Parks Foundation didn't install Minne in a Minneapolis Lake due to damage sustained the previous year and much needed restoration. As the Parks Foundation's leadership explored the best course of action, we produced a social media campaign called "Minne Vacation" which engaged Minne's 4,800+ Facebook fans and Twitter followers throughout the summer by inviting them to take photos of a Minne cut-out while on holiday. The Parks Foundation seeks to ensure everyone in Minneapolis lives within walking distance of healthy, active parks. In 2015, we championed neighborhood parks by (1) supporting and advising Save Our Minneapolis Parks, a citizen-led group advocating for additional tax-payer funding for local parks, (2) commissioning photojournalist Stephanie Glaros of "Humans of Minneapolis" to produce a profile series featuring portraits of neighborhood parks users, and (3) directing a generous gift to support city-wide swimming lessons, junior lifeguard training, and an additional water feature for the Jim Lupient Water Park.
