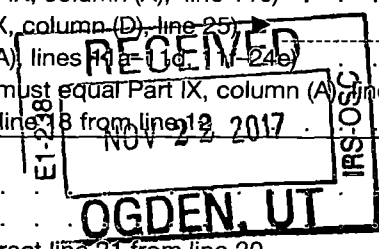

We work to end poverty and gender inequality by educating girls and creating community leaders in Peru. We enable young women to embrace education, believe in their own power, and dream of a life beyond the conditions into which they were born.

Peruvian Hearts girls' education and empowerment program provides 34 impoverished girls in Peru with full educational scholarships to attend secondary and post-secondary school, personal mentorship and guidance, opportunities to participate in community service, regular empowerment classes, and leadership workshops. The girls we support come from poor families with very limited economic resources and have dealt with extreme hardship. In addition to academic scholarships we provide our girls with psychological social support. Peruvian Hearts scholars have regular medical exams and receive full financial support for all healthcare costs. We provide our scholars with access to a psychologist, academic tutors, personal and professional mentors, and civic and community leaders. Our program puts a particular emphasis on personal growth and character development in addition to finishing a post-secondary education.

4b (Code:) (Expenses \$ 25,000 including grants of \$ 25,000) (Revenue \$ 0)
Misma Luna - Haven of Hope is similar to Peruvian Hearts' girls empowerment program and supports three girls who have faced great hardship in their youth in Lima. These girls receive the support they need to continue their education at the secondary and post-secondary school level. In addition to educational scholarships, the girls receive all room and board in addition to medical and psychological support. With guidance and encouragement, these girls will be able to complete their education and break the generational cycle of poverty into which they were born. Each of the girls gets to determine her own goals and career path by working directly with the program manager and mentors. Social skills and values are taught and reinforced at weekly group meetings and the girls also create a caring network of support for each other.

Cusco Medical Mission - This annual medical mission trip, led by a team of doctors from the United States, helps many needy people in Cusco and throughout the communities around the Sacred Valley. This project serves some of the poorest people from the rural communities around Cusco. In the towns of Urubamba and Lamay in the Sacred Valley, more than 600 people can be seen and treated each day by the medical team from the USA. The team also travels to high elevation communities around the Sacred Valley to visit patients that cannot travel to the larger towns in the valley.
