AFHA AmeriCorps "Enhancing Assets to Benefit to Benefit Communities deployed 26 National Service members throughout the state  
of West Virginia to support organizations serving within the themes of Conservation, Historic Preservation, and Heritage based  
Community Development. Members provided over 28,000 hours of service to their sites. Conservation service specifically included  
activities such as watershed restoration, environmental education, non-native species management, field data collection, tree  
planting, trail building and maintenance, environmental recreation support, archaeological support, among others. Historic  
Preservation teams supported organizations by providing hands on services for rehabilitation of historic structures. Community  
Development members supported organizations such as Mainstreet, Rural Development organizations, planning offices. All service  
members provided support for volunteer management activities for their sites and added greatly the volunteer capacity and output  
of their specific organizations. AC members managed over 1200 unique volunteers for their sponsoring sites in 2016, increasing  
capacity and supporting over 5,000 additional volunteer hours. Members provided direct service resulting in the improvement of over  
2,000 acres of public land in 2016.

AFHA AmeriCorps program "Growing Communities through Heritage Development" program deployed 12 AmeriCorps service  
members to sites throughout WV providing over 15,000 service hours. Members projects included support of organizational archives,  
education, interpretation, and outreach to the public, volunteer management, and social media development/management. Members  
managed an additional 300+ volunteers on behalf of their sponsor organizations and supported the implementation of volunteer  
management "best" practices.

AFHA Discovery Visitor Center hosted interpretive displays showcasing the Appalachian Forest Heritage Area's diverse natural and
