Our awareness campaigns, primarily through our run/walk events, reached an estimated 10 Million people for the 2016 fiscal year.

 Patient & Family Support Programs Fetal Health Foundation provides financial assistance for families diagnosed with a fetal syndrome. The financial assistance is awarded for families in financial need and that require travel to a maternal fetal medicine specialist that specializes in their particular fetal syndrome diagnosis. In 2016, over 20 families were awarded grants.
