OUR OUTDOOR HERITAGE IS GUIDED BY THE PUBLIC LANDS LEGACY ESTABLISHED BY PRESIDENT THEODORE ROOSEVELT AND HIS FELLOW VISIONARIES. THESE FORESIGHTED INDIVIDUALS UNDERSTOOD THE IMPORTANCE OF TAKING ACTION BOTH FOR THE SAKE OF THE RESOURCE AND FOR THE BENEFIT OF THE GENERATIONS THAT FOLLOW. EVERY CITIZEN OWNS A SHARE OF PUBLIC LANDS AND WATERS IN THE UNITED STATES. IT IS UP TO US TO DEFEND THIS HERITAGE AND ENSURE THAT OUR LEGACY OF STEWARDSHIP IS HANDED DOWN TO FUTURE GENERATIONS INTACT.
