The food council offered free healthy cooking classes in the community in 2016. This is through an ongoing collaboration with the University of Kansas Medical Center for community health improvement. ANDA believes healthy lifestyles are active lifestyles, so ANDA helps improve residents' health by making Argentine more walkable and friendly to pedestrians and families. ANDA has worked with public and private funding to replace more than \$1 million in curbs and sidewalks and continues to do so in the community. Plans are in place to develop a walking trail.

Summer Youth Program - The 2016 Summer Youth Program, Argentine Ambassadors, was funded by the Kansas City Board of Public Utilities and Youth Ambassadors. It is designed to provide creative and educational activities that increase self-confidence and resilience in underserved, teenage youth. The youth from Argentine were ambassadors of the Argentine Community. Our ambassador program was made up of a diverse group of youth, aged 14-17, with varying social and academic abilities. For eight weeks the Argentine ambassadors worked to tide the economic, academic summer slide by studying photography, documentary development, art, writing, life skills and soft job skills. A second summer youth program hired youth to serve in their community with neighborhood cleanup. The program helped them take pride in their community and strive to improve it.
