

Our mission is to improve lives through education. We envision a world where everyone has access to a quality education, is aware of this opportunity and has the resources to take advantage of it. Our work is grounded in the knowledge that an education gives people choices, and leads the way to a better and healthier life. Educated moms and dads raise educated sons and daughters. It's a cycle. The world still has problems, but billions of former students are tackling them.

REACH sends ninth-grade students on to high school who otherwise would not go. In rural Chiapas, less than half of middle school graduates continue their education. REACH aims to end this problem. Integrated into public school teachers' curriculum, REACH provokes ninth-grade students and their parents to consider and discuss why and how to enroll in high school through a series of year-long activities. Students watch a series of video interviews with role models—young people who speak their same indigenous languages and come from some of the same small villages as the students—that detail their experiences in high school and beyond. Student workbooks include information on the benefits of going to high school, on how to enroll, and on scholarship application instructions, as well as include activities dealing with themes of self esteem, identity, and goal setting. Teacher lesson plans help integrate the videos and workbooks with class activities and discussions. REACH 3.0 (2015-2016 school year) worked with 14,887 students in 428 schools, awarded 5,683 high school scholarships and caused 533 students to go to high school who otherwise would not have gone. REACH 4.0 (2016-2017 school year) is worked with 16,872 students in 516 schools. Continuation rates and scholarship numbers are pending. Including \$13,825 in in-kind donated professional services, total expenses are \$477,828

In 2016, Escalera built 1 school that served 30 students. Studies show that a new school with decent infrastructure increases student learning time by an average of 12%. Students who learn under tarps and in shacks lose about six weeks of school due to bad weather and teachers who show up less often. The 2016 high school classroom was built in Los Pozos, Huixtán.

REACH Scholarships cover high school enrollment fees for ninth grade students who continue on to high school. REACH's year-long curriculum is designed to motivate students to continue studying. Because the program is continuously monitored through a randomized control trial methodology, Escalera can definitively determine the effect of the program. Treatment schools are either given the curriculum and scholarships, or only scholarships. These two groups are then compared to control schools to determine what elements of the program are most effective in increasing student enrollment into high school and by how much.

Monitoring of Special Scholarships in Part III, line 3

Special scholarships are awarded to employees and their children who complete an application, provide proof of enrollment, and substantiate the requested scholarship amount.

Part I, Line 2 General response

Escalera's program strategy is to design (with empathy), prove (by testing), and scale (with evidence) solutions that end the school shortage in our lifetime. Empathy inspires design. We empathize with students to design solutions that work. Prove by testing. If it's not measured, it's not impact; and if it's not impact, it merits no investment. Results, not overhead ratios, are our metric for success. We're maniacs about metrics because of our passion for mission. A mission without metrics is meaningless; like a ship without a rudder, aimlessly wandering the vast ocean of philanthropy. Evaluation is difficult to do well; few do it, and even fewer do it well. We do it well. You wouldn't take a drug that hadn't been clinically tested, and we wouldn't scale a program that hasn't been rigorously proven. We use clinical tests to prove programs. We randomize to measure impact. We randomly assign two groups to participate or not participate in our program in what experts call a randomized control trial (RCT). This provides us with a control group against which we can compare results. The control group allows us to determine whether we had an impact because we can exclude the effects of other things that are difficult to see, like a student's innate talent. All evaluation has flaws, and an RCT is no exception. We've just found that an RCT, when done correctly, is less prone to error than most other methods. As part of Escalera's RCTs, ongoing on-site evaluations and surveys not only monitor the grants but ensure that the grants are used as intended according to the program design. Escalera maintains detailed documentation of all the evaluations, surveys, and awarding of grants to substantiate its evidence for success. For example, Escalera keeps the original evaluations and surveys completed by its personnel, which include receipts signed by each student, their teachers, and parent representative upon receipt of their scholarship. Escalera is careful to collect data that ensures its programs are reaching the poorest of the poor. Selection criteria includes baseline and endline primary data collection including data from the marginalization index that is calculated using settlement level data on a variety of
