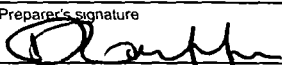

In 2016, the Abundance Foundation continued to provide program services and grant administration for the implementation of Out of Eden Learn (OOEL). OOEL is a unique, custom-built social media platform for students aged 3-19. The program groups students of similar ages from diverse geographical and socioeconomic settings together for collective learning experiences that are inspired by the journey of Pulitzer-prize winning journalist Paul Salopek. The Abundance Foundation provides program support and grants to organizations aligned with its mission to improve global health by strengthening local health systems and by training and supporting local health practitioners and leaders. The Abundance Foundation supported the Global Pediatric Alliance to improve maternal and infant health in Mexico and Central America in 2016, funding the capacity building of their small grants program. This grant program supports community-designed projects focused on improving maternal and infant health. In 2016, the Foundation funded the Inter-American Center for Global Health to perform research and development for the creation of a global health / planetary health education center in the Brunca region of Costa Rica.
