LINE 1a

John Hazen White's Lookout does not support or oppose candidates for political office, and does not otherwise participate or interfere in political campaigns. However, a print ad supporting a political candidate that was published in a local newspaper on October 26, 2016 erroneously contained the name of the charity, and the charity initially wrote a check for the \$700 cost of that ad. This was an error and was corrected immediately, as described below.

Lookout has never engaged in political activity since its formation in 2004. Mr. White took out the 2016 ad on his own initiative, not at the direction of or with the consent of the Board of Directors. The ad should have been styled as Mr. White's personal opinion, and the check should have been his personal check. His use of the charity's name and checkbook for the ad was a mistake.

Once the error was brought to the attention of Mr. White and Lookout, it was corrected immediately. Mr. White immediately disclosed publicly that the ad actually reflected his personal endorsement (rather than that of the charity) and that Lookout engages in no political activity and neither endorses nor opposes political candidates. The correction came so quickly that Lookout's check for the cost of the ad had not been cashed; the check was voided, and Mr. White actually paid the full cost of the ad from his personal funds. In addition, Lookout immediately sought legal counsel regarding the permissible scope of lobbying and political activity to guide Lookout's activities going forward. As a result of that counsel and guidance, Lookout has put in place policies and procedures to prevent an issue like this from recurring in the future.
