THEY MADE AN INITIAL CONNECTION TO MAIN STREET PROJECT BECAUSE THEY WERE SEEKING AN OPPORTUNITY TO ENGAGE IN SUSTAINABLE FARMING AND LOOKING FOR OPPORTUNITIES THAT ALIGNED WITH THEIR VALUES. THE YOUTH PLAN TO CONTINUE FARMING AS A WAY TO MAKE A LIVING. TWO OF THE YOUTH AGRIPRENEURS HAVE SECURED ACCESS TO LAND TO START THEIR OWN COOPS IN 2017.
