The entire collection is currently on long-term loan to the Center for Holocaust and Humanity Education (CHHE), located in Cincinnati, Ohio. The CHHE has incorporated the collection into its public exhibit to assist in teaching about the Jewish aspect of the Holocaust in World War II.
