**Explanation of \$1,181.45 Interest Restatement expense**

In preparing this 990-PF 2016 return it was determined that a copy/paste error in a spreadsheet for the 2012 return caused Interest Income to be OVERSTATED by \$1,181.45 in the 2012 return.

This error caused two general effects:

- 1) OVERPAYMENT of Excise Tax in 2012 by \$23.63 (2% of this \$1,181.45); and,
- 2) OVERSTATEMENT of Yearly Total Balances and Monthly Balances, ultimately causing higher Part X Minimum Investment Return and Part XI Distributable Amount requirements from 2012 through 2015.
  - the impact on 2012 Distributable Amount was approximately (rounded): \$30.00 (approximately 5% of the approximately \$600.00 average monthly increase in interest, accumulating by year end to the total of \$1,181.45)
  - the impact on 2013-2015 Distributable Amounts was approximately (rounded): \$60.00 per year (approximately 5% of the approximately \$1,181.45), or \$180.00 cumulatively over these 3 years.

The Foundation has NO interest in any re-filing aimed at recovery of any of these overpayments. NEITHER does the Foundation wish to burden the IRS (or the Foundation) with re-filing administrative efforts, and is further content to have over-supported its public charities.

In this 2016 990-PF return, the correction for the original overstatement of Interest Income has been entered as a line-item Certificate of Deposit expense (correcting for 2012 mis-statement of income), rather than as a debit to 2016 Interest, to avoid a mismatch and understatement of 2016 Interest Income versus the 1099 INT reports from financial institutions, and any ensuing questions/confusion.

With this change all balances now correctly align with banking statements, now aided by the consolidation during 2016 of all CDs to now be at one financial institution. In previous years several banks reported annual interest only, and not the monthly or yearly balances, which precluded the receipt of a record that would have prevented the 2012 error earlier.

We apologize for the error and any additional review this may have caused, and we hope that this explanation and correction within this 2016 990-PF return will suffice for all.
