Other Christian organizations provide programs and help to pay a portion of the production and broadcasting costs.

Part I Question 2 - The organization's procedures for monitoring the use of its grants and other assistance outside the United States:

Our staff plus a team of volunteers monitor the issuance of grants to the persecuted or displaced Christians and others that we help in the Middle East and North Africa. They make monthly reports to Endure International's president in the USA to report how the grants were used that month. The staff and volunteers meet regularly with grant recipients to assess their needs, pray with them, counsel them, and assist them in other ways.

Part I Question 3 - Activities per Region

We have a total of 8 offices and 26 employees in the Middle East and North Africa. While the various offices and employees sometimes have specialties where they do the bulk of their work, such as Bible translation, they each do all of the five ministry activities at various times. They all work together to minister to the needs of the Christians in the Middle East and North Africa in whatever ways the Lord presents to us and provides to us the skills and resources that we need.

We have 1 office and 1 employee in Europe. Our ministry there is primarily to refugees from the Middle East. It started late in 2016, and we expect the work with refugees in Europe to increase in 2017 and subsequent years.

As described in the notes about question 3 in part I, our team of staff and volunteers work with many individuals and families. While we help many of the same people for multiple months, the specific people that we help changes from month to month. We reviewed the monthly reports and believe that 190 is a very close estimate of the total number of individuals and families to whom we provided grants in 2016.

We completed that translation in 2016, therefore, this is the last year that we expect to have expenses for that program.

1. Internet Ministry: Endure International operates a web site in the Arabic language to teach the word of God. This ministry includes

In 2016 the cost of this ministry was \$21,938.

2. Orphanage Ministry. Endure International had assumed partial sponsorship of a worker at an orphanage in Morocco.

That worker has now retired in the USA and is receiving retirement benefits from Endure International.

The cost of this ministry in 2016 was \$13,656.

3. Church Planting. Endure International actively supports church planting efforts in a number of Middle Eastern
and North African countries through local missionaries and staff. A good number of house churches and Bible

study cell groups have been formed as a result of these efforts. In 2015 the cost of this ministry was \$7,142.

4. Bible Translation. In cooperation with other Christian ministries, Endure International adopted a people group
in a North African country. This includes translating the Bible into their language. We completed this translation in 2016.

Therefore, our expenses for the project were much smaller in 2016 than in previous years.

The cost of this ministry in 2016 was \$3,047.
