In 2016, the College Success Program awarded scholarships to approximately 265 students totaling \$1,353,500. Each College Success Arizona scholar is assigned a Success Adviser who is a full-time member of the staff. Advisers meet with each scholar at least twice per semester helping them identify obstacles to completing their college education and create a plan to overcome those obstacles. The obstacles could be money, family support, bad study habits, lack of college preparation, housing, emotional issues, etc. Success Advisers provide support and encouragement to their scholars, often reminding them they were chosen for this scholarship because College Success Arizona believes in them and their future. Since its inception in 2005, the Success Program has produced 380 graduates. We currently have a cumulative 6-year graduation rate of 67%, an overall retention rate of 72% and a freshman retention rate of 89%. These outcomes compare favorably with all state universities in Arizona. The Success Program also hosts an annual Leadership Symposium for our scholars each January. This all-day event is an opportunity for scholars to meet fellow students, hear from inspirational speakers, participate in teambuilding activities and attend various workshops. The college access component to our program, AzCAN (Arizona College Access Network), currently has 216 member organizations, comprising 444 professionals in the field of college access and success. They conducted one-on-one meetings with 108 members during 2016, welcoming them into the network and apprising them of the benefits they have as members. Thirty percent of our members participated in one or more AzCAN benefits throughout the year, including networking events, webinars, or data collection through National Student Clearinghouse. Approximately 71% found our monthly newsletter to be very beneficial to their organization. During the year we also delivered professional development to 177 professionals in the field, 25 of who completed the entire training series to earn certificates as Arizona College Access Professionals. Although College Success Arizona provides access, scholarships, mentoring and success services to our scholars and others, we strive to maintain a low overhead. Program services, excluding grants awarded, totaled \$1,477,593.
