THE ORGANIZATION WAS ACTIVE AT THE LEGISLATURE ON BUDGET POLICY, REGULATORY ROLLBACK AND PROMOTING INTELLECTUAL DIVERSITY ON COLLEGE CAMPUSES. DUE TO OUR EFFORTS, THE ORGANIZATION WAS SUCCESSFUL IN PASSING LEGISLATION ELIMINATING THE REQUIREMENT FOR NEW BUSINESS STARTUPS FROM PUBLISHING THEIR ARTICLES OF INCORPORATION IN THE NEWSPAPER, ALLOWING FOR THE DIRECT SHIPMENT OF WINE TO CONSUMERS, REFORMING OUR CAMPAIGN FINANCE STATUTES AND PROMOTING THE USE OF HOME-SHARING PLATFORMS IN THE STATE. THE ORGANIZATION ALSO SECURED ADDITIONAL RESOURCES FOR THE FREEDOM CENTERS ESTABLISHED AT OUR STATE UNIVERSITIES. THE ORGANIZATION ALSO DEFEATED SEVERAL CORPORATE WELFARE BILLS THAT PROVIDED SPECIAL INTEREST TAX BREAKS TO BUSINESSES AND INDUSTRIES.

THE ORGANIZATION ENGAGED IN A LENGTHY CITIZEN EDUCATION CAMPAIGN TO PROMOTE FREE SPEECH AND THE RIGHT OF INDIVIDUALS TO PRIVATELY SUPPORT CAUSES AND ISSUES THAT THEY BELIEVE IN WITHOUT THE FEAR OF HARASSMENT AND INTIMIDATION FROM THE GOVERNMENT. THE CAMPAIGN INCLUDED RESEARCH, POLLING AND A MEDIA EDUCATION CAMPAIGN GEARED TOWARD THE CITIZENS OF ARIZONA TO BETTER UNDERSTAND THE ISSUE.

THE ORGANIZATION ALSO WORKED TO EDUCATE ORGANIZATIONS AND RESIDENTS ON THE CONCERNS ASSOCIATED WITH PROPOSITION 206, THE MINIMUM WAGE INITIATIVE.
