SINCE OUR FOUNDING IN 2001, THE ORGANIZATION HAS ASSISTED HUNDREDS OF FAMILIES IN OBTAINING LIFESAVING SERVICES FOR THEIR CHILDREN, PRIMARILY WITH TREATMENT TRAVEL, FOOD AND LODGING ASSISTANCE. THIS OFTEN INVOLVES FINANCIAL SUPPORT FOR VERY DISTANT TRAVEL TO SPECIALIZED TREATMENTS, BUT ALSO HELP WITH BURDENS OF HOME CAREGIVING. WE ALSO PROVIDE SOCIAL SUPPORT PROGRAMS FOR THE FAMILIES ESPECIALLY THROUGH OUR MONTHLY FAMILY NIGHTS AND ANNUAL CAMP VICTORY. IN THE YEAR REPORTED HERE, WE SERVED 66 CHILDREN BEING TREATED FOR CANCER, ALONG WITH PARENTS/CAREGIVERS AND SIBLINGS A TOTAL OF 372.
