Principal activities include a facade restoration program, Saturday family activities, marketing downtown businesses promotions and events by others, actually organizing and implemently special activities to attract people downtown, and assisting with any projects that improve the safety, vibrancy, and appearance in the city's urban core.

Hanging Baskets and Flowers--the Downtown Association purchases 325 baskets of flowers that hang from the city street lamp poles throughout the downtown area as well as individual plants that are placed in large concrete sidewalk planters along the area sidewalks. During 2016, the ongoing maintenance was handled by a city-hired contractor for downtown maintenance overall.

Facade and Streetscape Improvements--Upon application, a downtown business and/or property owner may request up to 50% of the cost of renovations or the restoration of a building's exterior facade or attached architectural decoration. This has a goal of both increasing traffic to the business as well as a resultant increase in the sales. Major projects in 2016 included an in-ground lighting system to highlight the decorative features of a 1920s commercial facade, the replacement of windows in the second story of a 1905 building which had been previously covered with a metal sheeting and the windows totally blocked, and the installation of color-changing facade up-lighting on the most prominent facade of the 11-story Art Deco Larson Building--the most spectacular historic structure in downtown Yakima

Christmas Lighting and Events--For the 2016 Christmas season, the Downtown Association purchased new over-street and lamp post Christmas decorations, which can be used and augmented in the coming years. The Association also helped organize a Christmas lighted vehicle parade, a downtown city Christmas tree lighting, and attendant activities for children and families throughout December
