Glory Reborn provides compassionate and holistic care to marginalized moms and babies of Cebu, Philippines. In a tri-city area with a total population of nearly 2 million people, 46% of the population live on less than \$2 a day and nearly 15% of the population live on less than \$1 a day. The average expectant mother receives no prenatal care, has almost never heard the heartbeat of her baby, and will rarely see an ultrasound of her baby during her pregnancy. The combination of poverty and limited public health care creates an enormous problem for the people of the Philippines. At the very heart of Glory Reborn is the vision to build community. Our primary focus is to build community and relationship with pregnant women. In 2016, more than 200 babies were delivered in our clinic. And since the ministry was formed in 2003, we have celebrated close to 4,000 deliveries. We have a team of 41 staff, including volunteers, who help care for our moms and babies.
