Gospel events, services and conferences were held in Brazil, Nepal, Bangladesh, Indonesia and in the United States, totaling approximately 150,000 persons in attendance. We held a total of 14 gospel events in five countries.

Commonly, all churches of different denominations work together in our events, and hundreds of volunteers join efforts to organize and participate these events.

A total of 8 to 15 events are held within one week in one city, most of which lay in poor, rural areas.

We encourage American churches to bring youth or adult teams. We take along and host teams overseas several times a year thus obeying the Great Commission.

Distribution of literature and food donations. In 2016, about 11 tons of food were given out in poor neighborhoods personally by church teams, youth teams. Roughly 20,000 bibles or other Christian literature were donated.
