| MPI RISING FILMMAKERS PROGRAM. THE MPI RISING FILMMAKERS PROGRAM OFFERS "NEXT-TIER" OFFERINGS DESIGNED FOR RISING FREEDOM-ORIENTED FILMMAKERS AS THEY ADVANCE IN THEIR CAREERS. THE PROGRAM PROVIDES FINANCIAL SUPPORT FOR PARTICIPANTS' WORK, ALONG WITH MENTORING AND CONTINUING EDUCATION ON FILM-RELATED MATTERS SUCH AS SELF-DISTRIBUTION, MARKETING AND SOCIAL MEDIA, AND STORYTELLING. IN RETURN, FILMMAKERS HELP MPI TALENT SCOUT, BUILD OUR NETWORK, AND PROVIDE TECHNICAL ASSISTANCE TO OTHER PARTICIPANTS AND GRANTEES. IN 2012, THE MPI RISING FILMMAKERS PROGRAM WON THE PRESTIGIOUS TEMPLETON FREEDOM AWARD FOR INNOVATIVE NEW MEDIA. MPI'S TALENT DEVELOPMENT WORK IS RECOGNIZED BY THE ENTIRE FREEDOM MOVEMENT AS A FORCE OF INNOVATION AND IMPACT. MPI HAS SUPPORTED MORE THAN 100 RISING FILMMAKERS IN THE SIX YEARS SINCE THE PROGRAM WAS LAUNCHED, AND WE ARE CONSTANTLY GROWING AND IMPROVING THE PROGRAM. AN MPI RISING FILMMAKER FELLOWSHIP PROVIDES A MAJOR CAREER BOOST FOR EMERGING FILMMAKERS AND A HUGE RETURN ON INVESTMENT FOR DONORS WHO WISH TO SEE HOLLYWOOD SEEDED WITH TALENT COMMITTED TO FREEDOM - AND WHO WISH TO SEE THE NONPROFIT WORLD EXPAND ITS REACH THROUGH FILM. WE FORM FULL-SCALE COLLABORATIVE PARTNERSHIPS WITH SELECTED ADVANCED FILMMAKERS. SUCH PARTNERSHIPS INVOLVE JOINT FUNDRAISING, JOINT CONCEPT DEVELOPMENT, JOINT PRODUCTION, AND JOINT MARKETING EFFORTS.
