

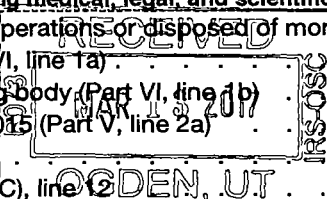

Public Online Information Services –
Erowid Center developed, maintained, and provided free access to an online collection of more than 65,000 documents, images and other media files related to psychoactive plants and drugs. More than 15 million people accessed the information in this online archive in 2015. The collection contains essays and articles authored by a broad spectrum of contributors including health care professionals, substance abuse counselors, toxicologists, chemists, therapists, law enforcement agents, lawyers, anthropologists, writers, media, educators, and the general public. Note that our online Experience Report Collection is tracked as a separate program service.

EcstasyData / DrugsData Lab Testing –
Erowid Center runs a laboratory testing program that analyzes the contents of ecstasy tablets, pharmaceuticals, research chemicals, novel psychoactive substances (NPS), and other street drugs. Members of the public submit samples to a DEA-licensed laboratory and the results are published online at EcstasyData.org. The purpose of the project is to collect, manage, review, and present laboratory testing results, including those from other US and international organizations. The information is made publicly available to help harm-reduction efforts, medical personnel, researchers and the general public. In 2015, 528 samples were tested through the project. These results were published along with results for an additional 110 samples tested by other organizations. An average of 3,570 people viewed our testing results online each day.

Archiving & Transcription of Historical Documents
Erowid Center's mission includes collecting, organizing, and preserving resources about psychoactives as historical records for the future. In 2015, Erowid's primary activities in this domain were, 1) transcribing and publishing pharmacology and chemistry notebooks from the Shulgin Archives (a transcription of Shulgin Pharmacology Notebook #6 was completed and published online), 2) helping to manage the developing team working on processing documents from the Shulgin Archives, and 3) accepting small collections of historical documents and artifacts from others to be organized, indexed, digitized, and preserved.

1. Public Online Information Services — (expenses: \$81,066.15, grants: \$0, revenue: \$0)

Erowid Center developed, maintained, and provided free access to an online collection of more than 65,000 documents, images and other media files related to psychoactive plants and drugs. More than 15 million people accessed the information in this online archive in 2015. The collection contains essays and articles authored by a broad spectrum of contributors including health care professionals, substance abuse counselors, toxicologists, chemists, therapists, law enforcement agents, lawyers, anthropologists, writers, media, educators, and the general public. Note that our online Experience Report Collection is tracked as a separate program service.

2. EcstasyData / DrugsData Lab Testing — (expenses: \$77,272.30, grants: \$0, revenue: \$46,635.25)

Erowid Center runs a laboratory testing program that analyzes the contents of ecstasy tablets, pharmaceuticals, research chemicals, novel psychoactive substances (NPS), and other street drugs. Members of the public submit samples to a DEA-licensed laboratory and the results are published online at EcstasyData.org. The purpose of the project is to collect, manage, review, and present laboratory testing results, including those from other US and international organizations. The information is made publicly available to help harm-reduction efforts, medical personnel, researchers and the general public. In 2015, 528 samples were tested through the project. These results were published along with results for an additional 110 samples tested by other organizations. An average of 3,570 people viewed our testing results online each day.

3. Archiving & Transcription of Historical Documents — (expenses: \$31,103.69, grants: \$0, revenue: \$0)

Erowid Center's mission includes collecting, organizing, and preserving resources about psychoactives as historical records for the future. In 2015, Erowid's primary activities in this domain were, 1) transcribing and publishing pharmacology and chemistry notebooks from the Shulgin Archives (a transcription of Shulgin Pharmacology Notebook #6 was completed and published online), 2) helping to manage the developing team working on processing documents from the Shulgin Archives, and 3) accepting small collections of historical documents and artifacts from others to be organized, indexed, digitized, and preserved.

4. "Erowid Extracts" Educational Newsletter — (expenses: \$29,654.86, grants: \$0, revenue: \$0)

Erowid Center prepared two issues and published one issue (#27) of our newsletter including new educational articles and information about psychoactives and other related topics. We print 2,500 copies of each issue of this 28-page advertisement-free publication and distribute them to members and the public. A full-issue digital version and constituent articles are later published online for free access by the general public. More than 10,000 people viewed/downloaded the full issue #27 in the year following publication and thousands more read individual articles online.

5. Education and Educational Materials /Gifts — (expenses: \$29,302.35, grants: \$0, revenue: \$10,709.82)

Erowid Center provided direct education services by answering questions from the public. We distributed books, information handouts, and teaching materials about psychoactive drugs, plants, practices, and technologies to members and the general public, furthering our educational mission.

6. Drug Trend & NPS Tracking — (expenses: \$27,834.35, grants: \$0, revenue: \$0)

Tracking new psychoactive medicines, technologies, “Research Chemicals”, “Novel Psychoactive Substances”, “NPS” (or incorrectly “Synthetic Drugs”), is one of Erowid Center’s areas of expertise. With the objective of educating the public on the risks and benefits associated with the use of emerging drugs, we 1) monitor the availability, use patterns, and effects of these substances through consultation with volunteers, allied organizations, medical professionals, and online forums; 2) analyze chemicals through our EcstasyData/DrugsData program; 3) coordinate between experts in the field; 4) educate writers and authors for media, news, and books; and 5) publish information about these substances online and in print.

7. Experience Report Collection — (expenses: \$18,751.12, grants: \$0, revenue: \$0)

Erowid Center solicits, reviews, and publishes first-hand reports of people’s experiences with psychoactive plants, drugs, and technologies. This program produces vital information about psychoactive materials as well as aggregate data about why and how people use psychoactives, both for current factual documentation and for the historical record. Reports are reviewed and edited before being published. Trained volunteers perform much of the reviewing work under the supervision of Erowid staff. The resulting data is used by researchers, academics, and medical professionals both for educational purposes and as source data for peer-reviewed articles and publications. There were approximately 35 million experience reports viewed/downloaded during 2015.

8. Research, Surveys, & Research Improvement - (expenses: \$10,777.89, grants: \$0, revenue: \$0)

Erowid Center improves scientific, medical, and sociological information about psychoactives and those who use them by promoting participation in studies and surveys produced by academics, educational institutions, related organizations, and Erowid Center itself. We work directly with scientists—in areas where we have specialized knowledge—to help design credible studies and provide editing, reviewing, and fact-checking for resulting academic publications. Erowid Center improves information by conducting and promoting surveys about psychoactive drugs: health issues, use patterns, demographics, lifetime perspectives, and trends of newly developed drugs. In 2015, Erowid initiated an opioid harm reduction research project in collaboration with a team of clinical toxicologists and addiction experts. We conducted two surveys on perceptions about opioids and their use, as well as one about the use of psychoactive drugs at large festivals. Over 10,000 survey responses were gathered. One article about psychoactive use at festivals was published. Erowid also authored a book chapter and co-authored a peer-reviewed paper about *Mitragyna speciosa* (kratom).

9. Events & Conferences — (expenses: \$8,930.25, grants: \$0, revenue: \$1,000)

Erowid Center conducts educational outreach in person at conferences, seminars, and festivals. In 2015, Erowid sent representatives to two events. We participated in the Psymposia conference in Amherst, MA in April 2015. Erowid Center gave three presentations, focused on Drug Trends and NPS tracking, electroceuticals, and the transmission of hard-won wisdom between generations. Erowid Center also provided NPS information at a 500-person event in California. At both events, we met with supporters, members, and donors to discuss issues related to psychoactive drug education.

10. Information Network - EEN - (expenses: \$2,499.44, grants: \$0, revenue: \$0)

Erowid Center has built a network of both professionally-trained and self-taught experts with knowledge about psychoactive plants, chemicals, and technologies. Erowid Expert Network (EEN) members volunteer to share their
