We initiated a movement towards privatized mental health care and serve as a model for future group homes in Armenia for the benefit of this vulnerable population.

In 2016, we provided ongoing long-term residential care to fourteen residents. We continued our in-home programs to encourage the social, physical, mental and vocational well-being of our residents. Through these weekly programs and through the expertise of the staff, we have facilitated community and societal integration. Resident life interviews, Individual Care Plans and Positive Behavior Support Plans, which include data from the International Classification of Functioning, Disability and Health, continue to serve our residents and provide quantifiable data in regard to growth, well-being and the development of our residents.
