A new goal of funding a total of 1,000 wells in five years was set in April 2014. Wellspring had pledges for 101 more wells at the end of 2016. Wellspring for the World also fundraised thru the Fargo Marathon. A total of \$71,521 was contributed directly to World Vision, this represents over 14 additional wells that were funded.
