1. They are the President and the Secretary, respectively, of American Friends of the Re'ut Institute, a California corporation.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

I.

The name of this corporation is REUT USA.

II.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purpose of this corporation shall be to support and promote research and programs designed to ensure prosperity and resilience for Israel and the Jewish People, and to tackle some of the toughest challenges facing them, while making a significant and distinct contribution to humanity, including, without limitation, those programs of The Reut Group - From Vision to Reality (R.A.), and to carry on other educational, scientific and charitable activities associated with this purpose as allowed by law.

III.

- (a) This corporation is organized and operated exclusively for the charitable purposes set forth in Article II hereof within the meaning of section 501(c)(3) of the Internal Revenue Code.

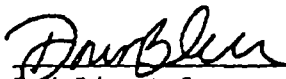
