- The "Senufo: The Art and Identity in West Africa" exhibit was held at three member museums during 2015-2016: the Musee Fabre in Montpellier, France and the Cleveland Museum of Art, and the St. Louis Art Musuem in the United States.
- The "Georgia O'Keeffe and Her Photographer Friends" exhibit was held at the Museum of Grenoble, France in November 2015 through February 2016.
- The "L'Art et la matiere" exhibit was held at the Musee Fabre of Montpellier, France, from December 2016 through July 2017. Through original devices, the tactile gallery offers new methods to visit a museum developed by blind and the visually impaired people so everyone can appreciate sculpture. This universal, inclusive and citizen project was based on a unique partnership with the Louvre and the Federation des aveugles de France Languedoc- oussillon and also benefited from the Montreal Museum of Fine Arts.

FRAME colleagues and young people involved in the program on both sides of the Atlantic participated in a public forum held at the Montreal Museum of Fine Arts. This project shared values of dialogue, tolerance, inclusion, civic engagement and mutual understanding. It also aligned with the host museum's humanist mission to offer its collection, expertise and facilities to serve the community with the aim of encouraging dialogue and harmonious co-existence while relying on the role of art as a vehicle for peace and social cohesion.

- "Bridges Across Borders - Bilingual Change Through Art" - an educational program originally launched in 2014 by the Musee des Beaux Arts of Bordeaux and College Cassignol, Bordeaux (France) and the Virginia Museum of Fine Arts and Collegiate School of Richmond (United States).
