Allocations were made to the Fanconi Anemia Research Fund to support medical, scientific and treatment research of Fanconi anemia and its related cancers. \$250,000 was allocated to fund research entitled Targeting Lipid Metabolism in FA for the Prevention and Treatment of Squamous Cell Carcinoma (SCC). This research is being conducted by Susanne Wells, PhD, Cincinnati Children's Hospital Medical Center. Dry and moist skin (e.g., in the mouth) plays a critical role in maintaining a barrier against environmental insults and cancer. Based on new data, this team believes that individuals with FA may have an impaired barrier and this may be why they are at risk for SCC. Specifically, data shows that FA pathway loss impairs adhesion between skin cells. FA pathway loss also stimulates motility in cells that would otherwise be stationary, this is particularly interesting, given that cancer cells have reduced attachments to their environment and tend to be highly motile. Moreover, the link between the FA pathway and changes in the skin may be due to altered lipid levels and Rac1 signaling. Fortunately, it is possible to restore lipid levels and signaling to normal with existing drugs and in this proposal it will be determined if this can normalize skin architecture to prevent and treat FA SCC. \$70,000 was allocated to fund research entitled Targeting LNK(SH2B3) to Ameliorate Hematopoietic Stem/Progenitor Defects in Fanconi Anemia. This research is being conducted by Wei Tong, PhD & Joel Greenberger, MD, PhD, The Children's Hospital of Philadelphia. Dr. Tong recently discovered a novel gene called LNK that regulates bone marrow cell survival and growth. She found that loss of LNK in a mouse model of FA restores normal bone marrow functions and increases stem cell longevity. This new grant will allow Dr. Tong to explore the mechanisms underlying this important discovery and to develop new strategies to inhibit LNK to improve bone marrow function in Fanconi anemia. This work will also advance efforts to correct Fanconi mutations by gene therapy. An allocation of \$5,000 was made to Fanconi Research Fund for general funding of FA research. Allocations were made for scholarships to enable FA affected families to attend Camp Sunshine. \$1,686 was allocated for Camp Sunshine scholarships. Camp Sunshine provides respite, support, joy, and hope to children with life-threatening illnesses and their immediate families from around the world through the various stages of their journeys. During Fanconi anemia week at Camp, families find support and encouragement from others affected by this disease. In addition there are in-depth seminars presented by a wide range of FA specialists presenting information on the most current therapies and advancements. The presenters remain available to families for individual questions and consults. Allocations were made to the University of Colorado Foundation. \$50,000 was allocated to the University of Colorado Foundation for the Kenneth R. Atkinson MD, Endowed Memorial Scholarship at the University of Colorado School of Medicine. These funds will be used to provide undergraduate scholarship awards for needy students enrolled in the School of Medicine at the University of Colorado Anschutz Medical Campus. Scholarships will be given to 4th year medical students whose plans are to practice primary medicine. Recipients will be determined based on both financial need and academic merit, as determined by the University. Preference will be given to students planning on practicing family medicine in the state of Colorado and those who have expressed interest in providing medical care to historically underserved or marginalized communities. underserved or marginalized communities.
