We created open source software and open licensed (Creative Commons) training materials. In 2016, we launched our platform Check as a project to promote distributed election monitoring using journalism students and media partners. This was one of the largest single day collaborative journalism projects ever undertaken with more than 660 journalists filing 1200 reports which in turn generated hundreds of articles on election day. The organization we helped found, First Draft News, generated research, curriculum, trainings and projects to a global community. Our research on translation needs in refuge camps, Bridge for Crisis, provided a case for improved tools and linguistic data resources for crisis.
